- Grantee must be located in the Boca Raton/Delray Beach area
- Project must include Jewish content or be sponsored by a Jewish organization
- Requests may be awarded for up to \$1,800
- Grantees must personally have a tax-exempt 501c3 status or be sponsored by an organization with a tax-exempt 501c3
